Editorial Guidelines

(Articles)

Font: Tahoma, 12 pts, spacing 1½.

Footnotes are to be numbered separately for each article. The numbers of the footnotes in the text are to be placed in front of the punctuation. Each footnote ends with a full stop. Please observe the guidelines for creating your footnotes below.

Font: Tahoma, 10 pts, single line spacing.

For publishing purposes, the author's full address should be noted on the last page of the article. Beyond that please note the author's official address (Institute, University etc) which will be published on the backside of the respective journal's volume.

Please e-mail your article in electronic form (* doc./*docx) to your supervising editor, who will organize the further review process and serve as your contact. Align your text flush left without using hyphenations.

How to submit your manuscript:

a) Text

Headlines: refer to the template ZNR_Beitrag.dot.

The articles should be organized by subheadings in the order I-A-1-a and conclude with a summary or overview. The subheadings are repeated before the text as a table of contents (except for very short reports). A subheading may provide further information.

Legal Profession and Education, D. Legal Learning, E. Custom and Law, F. Maritime Law, G. Private and Commercial Law, H. Crime (including Witchcraft), I. Women and the Law, J. Slavery; IX. Conclusion.

Quotations from printed or archival sources must be set in „inverted commas“.

b) Footnotes:

Please note the exact beginning and end of your quotation (eg p 5-9); use commonly known abbreviations without punctuation (Vol, Ed, eg).

Citing monographs: First name (abbreviated, dot.) surname (both *italicized*; multiple authors divided by –), Title (if necessary: = series, vol), year of publication (if necessary: 2./3. edition, placed before the year), pages (without writing „p.“).

In the case of a multi-volume work, the volume number is placed after the title or subtitle, separated by a comma.

For unpublished dissertations, diploma theses and other unpublished manuscripts, the type of writing and the place of publication are given after the title of the work: Title, - Type of work University year of publication.

Piłsudski*, Pisma zbiorowe Józefa Piłsudskiego, Vol 4, 1937, 7; *I. Mosser*, Der Legitimismus und die Frage der Habsburgerrestitution in der innenpolitischen Zielsetzung des autoritären Regimes in Österreich (1933–1938), Diss. Univ. Wien 1979; *J. Bodner*, Das Habsburgergesetz, Dipl.-Arb. Univ. Innsbruck 1994.

Citing compilations: First name (abbr., dot.) surname (both *italicized*), Title, in: First name (abbr., dot.) surname of the editor (*italicized*; multiple editors divided by –) (Ed), Title (if necessary: = series, vol), year of publication (if necessary: 2./3. edition, placed before the year), exact pages without using „p.“, cited page.

Examples:

Soziale Kommunikation in Mittelalter und Früher Neuzeit (= Norm und Struktur 7), 1997, 29–47, hier 41; *A. Cordes*, À la recherché d'une Lex Mercatoria au Moyen Âge, in: *O.G. Oexle - P. Monnet* (Hrsg), Stadt und Recht im Mittelalter. La ville et le droit au Moyen Âge, 2003, 118–119.

Citing articles in journals: First name (abbr., dot.) surname (both *italicized*), Title, in: Journal year (if necessary: vol and issue), exact pages of the cited articles (without using „p.“), cited page.

Examples:

W.M. Gordon, Scotland – Legal History, in: ZNR 2002, 156–171; *H. Hofmann*, „In Europa kann's keine Salomos geben.“ Zur Geschichte des Begriffspaars Recht und Kultur, in: JZ 2009, 1–10, hier 9; *W. Schubert*, Das Abzahlungsgesetz von 1894 als Beispiel für das Verhältnis von Sozialpolitik und Privatrecht in der Regierungszeit des Reichskanzlers von Caprivi, in: ZRG (GA) 1985, 130–167, 133–135; *William Monter*, The Historiography of European Witchcraft. Progress and Prospects, in: Journal of Interdisciplinary History 1971/72, 435–453. *E. Kadens*, The Myth of the Customary Law Merchant, in: Texas Law Review 2012, 1153–1206.

Citing newspapers:

First name (abbr., dot.) surname (both *italicized*), Title, in: Newspaper, date (day.month.year), page.

Example:

E. Dombrowski, Bayern, Ruhr und Rhein. Die Industrie und die Reparationsleistungen, in: Berliner Tageblatt (Morgen-Ausgabe), 23.10.1923, S. 1–2.

If a publication is referred to multiple times, a shortened citation of the form „*author* (Fn. 1), page“ can be used from the second reference onwards; to avoid confusion, a shortened title may be added:

Korinek (Fn 32); *Stollberg-Rilinger*, Verfassungsgeschichte (Fn 4); *L. Ostwaldt*, Was ist ein Rechtsritual?, in: *Schulze* (Ed), Symbolische Kommunikation vor Gericht (Fn 12), 125–152.

If a publication is referred to in the following footnote, „ebda 1“ can be used.

In case of citing titles in foreign languages except German, English, French and Italian, please add a translation of the work's title in (brackets).

Please do not forget about noting URL and the date of your last access when using sources from the internet.

Abbreviations

Do not use abbreviations within your text. In the footnotes, please use only commonly known abbreviations without punctuation (Ed, eg, vol). In order to avoid misunderstandings, please create a list of abbreviations and put it in front of your first footnote (eg when using archival sources).

Abstract

Each article starts with an abstract (1.000 to 1.500 characters incl. blanks) placed between headline and the table of contents.
